CREST: On a mural crown argent three fleur-de-lys per fess azure.

"Continuer mes découvertes" MOTTO: (Blue with silver lettering)

SHIELD: Azure, a compass rose girony or and argent, with the points per saltire counter-girony of the same, and a chief wavy barry of wavy six pieces azure and argent.

CREST: As a college named after the founder of the City of Quebec, long the principal town in New France, we draw attention to this by using a silver mural crown charged with three blue fleur-de-lys. It evokes not only the tower as the principal architectural feature of the College by representing the crenellated top of a heraldic tower, but also one of the more important achievements of the man after whom the College is named.

SHIELD: Disposition of charges:

> Compass rose below waves - divides focus of interest almost equally between the two symbols - compass rose of red and silver picks up on red and white, our national heraldic colours, and is therefore not inappropriate for the compass rose of Champlain who discovered so much of Canada.

Waves - symbolize not only river of Champlain's voyages, but also Otonabee - the river beside our own College.

In summary, the compass rose recalls Champlain's role as explorer and cartographer.

The wavy lines, taken over from the Trent logo and the Peterborough coat of arms suggests the Otonabee River.

The mural crown evokes the architecture of the College.

The motto comes from Champlain's diaries - "Continue my discoveries".

These are just ramples of what is contained in Champlion's College Office files.

Sincerety:

- 7. The Dean of Men asked the Committee to give thought also to proposals for a name for the women's college in the City, in the likely event that it expands beyond Catharine Parr Traill House. The Committee agreed to do so.
- 8. In general, the Committee agreed that the names of some colleges should honour Canadian persons of national significance, like Samuel de Champlain. Such names as Sir William Osler, Frederick Banting, and Wilder Penfield were mentioned as possibilities for later consideration.
